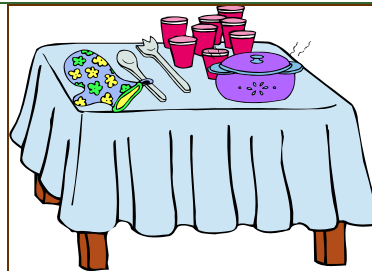

## SICK RACCOONS AT LARGE!!!

A week ago, three separate incidences occurred in Spruce Creek involving sick raccoons. This first incident, which occurred at a barn on Spruce Creek Drive near Leatherwood Rd, was reported. The National Park Service was contacted and informed us that we needed to contact the TWRA and/or the Health Department. The Resource Officer went ahead and made the call to the TWRA. After hearing the behavior that the raccoon was exhibiting, they said to put the animal down and dispose of it. The second incident was two days later on the back side of Deer Haven Trail. The raccoon was put down. There was a third sighting on the Evergreen Trail but was not reported until several days later.

Doug Lamb, the TWRA Ranger for Fentress County, said that the raccoons were suffering from distemper. The signs are: oblivious to their surroundings (not responding to dogs barking and charging at them, objects being thrown at them), walking like they are drunk, continuously wiping their mouths and turning around in tight circles. Mr. Lamb said that they will eventually die, but if we feel so inclined, we can put them down.

There were numerous cases reported of raccoons with distemper in Fentress County last summer. The number one problem is that they find a food source and they share it. This spreads saliva between the `coons and any pets that you may have and therefore the disease is spread. (It can also be spread from contact with infected blood or a bite). If you know that raccoons are getting into your feed (dog/cat/horse) **PLEASE** take the necessary steps to curtail access to the food source - You will stop being part of the problem.

**REWARD OFFERED FOR BEAR KILLING IN**

**BIG SOUTH FORK NRRA**

The Humane Society of the United States and The Humane Society Wildlife Land Trust are offering a \$2500 reward for information leading to the arrest and conviction of the person or persons responsible for illegally killing a black bear in Scott County, Tenn. The HSUS and HSWLT reward adds to an existing \$500 from the National Park Service. An adult female bear was found dead in the BSF area on Thanksgiving Day. It is believed that the bear was the mother of two cubs who would likely not survive without her. "Whoever is responsible for this illegal killing took the life of one bear and likely left two orphaned cubs to die a slow death," said Leighann McCollum, the Tennessee state director for The HSUS.

Plugging of abandoned oil and gas wells to continue in BSF

Fourteen abandoned oil and gas wells in the park will be plugged and reclaimed this spring and summer. The project will be completed with federal funds through a cooperative agreement with TDEC. This project will improve safety conditions for visitors and protect natural resources in the park.

In the interest of visitor safety and overall project success, temporary closures of site-related access roads and trails may be necessary.

Experience the excitement of breadwinners who were able to find work in logging and lumber mills, coal mining, the shirt factory, the chicken plant and other industry related work in the county. Today, tourism plays a large role in the county, thanks to the attractive recreational activities in and around Fentress County.

You are invited to take a day, a few days or a week to see first hand some of what makes Fentress County such a great place to visit, live, work and play.

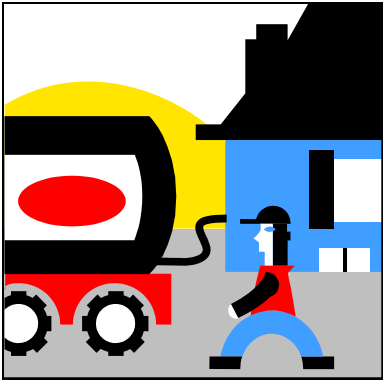
