## YEARLY MEMBERSHIP DUES FOR 2013

This is YOUR association and your participation is greatly welcomed. You must be current on your dues to qualify for a position on the board.

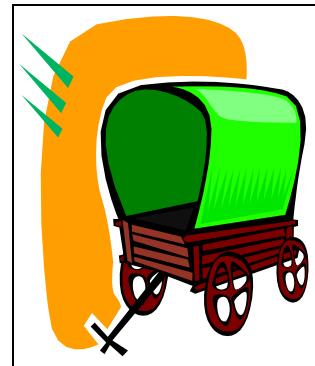
### O&W Trail Now Open to Wagon Use

The park begins a pilot project to allow wagons on the O&W trail *on a limited basis* to determine if the use of wagons is practical and desirable.

Wagons will have access points at Mill Creek, Zenith, and Tar Kiln Trail.

During the pilot period, *wagon use will be restricted to Monday through Friday only*. The route will continue to be open to horses, mountain bikes and pedestrians every day.

To access the trail by wagon, stop by the Big South Fork park headquarters to sign out a key that will allow access through the gates at these locations.



### Benefit Ride to Support Best Friends Sanctuary Sponsored by True West Campground



### Accounting of Proctor Ridge Trail Re-route:

The project costs came in better than we the estimate and we received a refund!

SCTA contribution	\$5,000
Gerndt Family contribution	<u>\$2,500</u>
Total allocation	\$7,500
Total Cost	-\$ 7,250
<b>Refund to SCTA</b>	<b>\$250</b>

We still have some water bars to install and interlocking stones at the creek crossing. (Future work day) SCTA is responsible for maintenance of the trail for one year per our agreement with the Park Service.

**NEW TRAIL DIRECTIONAL SIGNS:** At the last board meeting, the subject of installing new directional signs within the Spruce Creek Trails system was discussed . We are looking into the design and cost of materials. Dave Duchon has graciously volunteered to make them for us. We will be contacting True West Campground, Timber Ridge Campground and Saddle Valley Campground for their support in this endeavor.

### EAST FORK TRAILS YEARLY PASS FOR SPRUCE CREEK TRAIL RIDERS

As a member of a club, we are qualified to get an East Fork Trail Pass. At a reduced rate! *We must sign up as a group each year.* The cost is \$43.80 per person per year. If you are interested in joining, call Brenda Lawson at 879-2781 or Pam Dawson at 752-2250. They will need your name, address and phone number and you must get them the check (made out to East Fork Stables) by this year's April potluck (April 27th) Pam has to turn in the information by May 1st.

On your first trip to East Fork, you must check in at the office and sign a release of liability and present your current Coggins to them to make a copy. Then you will receive your yearly pass and you will not be required to check in again. Just show up and ride!
