Service plotted a 1 ½ mile reroute of the trail.	<i>Several board members walked it with Park Svc on April 30, 2012 to replace markers and determine estimated effort</i>	<i>JUNE 2011 Park Service asked us to “adopt” this portion of Proctor Ridge Trail. July 5<sup>th</sup> 2012 Board agreed to allocate \$1,500 to this project. Danny will evaluate when weather permits</i>
2	04-2012	<b>OPEN</b>	The Spruce Creek Drive pavement crossings by the pavilion and Saddle Drive are slippery and should be improved/marked for equestrian traffic	<i>Danny Hatcher</i>	<i>Tar and other materials purchased...still need pea sized rock. Brian Machette is willing to help.</i>
3	04-2011	<b>OPEN</b>	Indian Trail by the Gibson property is washed out again. Needs rock and some leveling.	<i>Danny Hatcher</i>	<i>Danny will order several loads of rock/crusher run to work on these items</i>
4	04-2012	<b>OPEN</b>	A deep wet spring continues to reappear and erode the trail beside Jaimie W. property.	<i>Danny, Sharon, Laurie, Tracey</i>	<i>A small, sturdy bridge over the area is probably the best solution. Should include in a future work day</i>
5	08-2011	<b>OPEN</b>	Trail in front of Pickards needs grading/rock/crusher run again. (apparently had hydrant leak)	<i>Danny</i>	<i>Danny will order several loads of rock/crusher run to work on these items</i>
6	06-12-2010	<b>OPEN</b> <b>Moved from 2010/2011 List</b>	Evergreen Trail – behind Cathy & Scott (Vet) and Fultons’ property has washed out/-needs additional drainpipe or other work. If the trail could be relocated, perhaps this would improve the on-going problem.	<i>Tracey and Danny Hatcher</i>  NOTE: determined that this is <b>not</b> Keith Holly’s land	<i>Danny put down 2 loads of rock on July 3 which provides improvement.</i>  <i>Tracy had discussion with owner-Scott said he would probably allow us to reroute the trail...drainage also affects DeWitt Shelton’s land</i>

Linder turn back/trail maintenance doc. for suggestions. <i>Creek crossing area owned by R. Rains who will allow us to reroute if it will help. Will assess in the fall.</i>
9	09-2010	<b>OPEN</b> <b>Moved from 2010/2011 List</b>	Wildcat Den trail-severe drop off in several places is washing out again, plus area down to the creek is washed out/alternate path has roots sticking out. Should probably remove tree stump down by the creek area. Note: The trail goes across a tract of land owned by the Sloan family which is not part of Spruce Creek.	Sharon and Dino (works for Danny) installed 4 cross tie step downs at the first big drop off which did help. Sharon, Ricky, Bev, Pete, and Laurie walked it again 11-22-10 as part of Board meeting. <b>JUNE 2011</b> Roger and Lee did some work to clear around stump	Note: the Ridge Top trail folks are willing to help and have worked on the other side going out of the creek. <i>Wallace Linder is the care taker the Sloans (owners) indicated they are open to possibly re-routing/ allow us to build some switch backs.</i> Another alternative may be to use sackrett to build walls/more secure step downs.
